

## SUNA Conditions of Entry

1. For the comfort, safety and enjoyment of all event participants, members and staff, the following conditions of entry ('Conditions of Entry') apply to any person entering, accessing, or otherwise using the SUNA Complex (or who wish to do so, as the context may so require), whether or not they are a member of SUNA ('Attendee').
2. SUNA applies these Conditions of Entry with the safety and wellbeing of children as a foremost priority.
3. In these Conditions of Entry, 'SUNA Complex' means the facility at Wilfred Taylor Reserve, Morphett Vale, SA 5162, including the Clubhouse inside and the courts immediately surrounding the Clubhouse.
4. These Conditions of Entry are to be read in conjunction with the conditions that apply to all specific events. Please refer to the relevant ticket information if applicable and specific event information for further information.
5. Attendees who do not comply with the Conditions of Entry will not be permitted entry or will be denied ongoing entry into the SUNA Complex. Attendees who have been admitted but subsequently fail to comply with the Conditions of Entry (as determined by SUNA in its sole discretion) may be removed from the SUNA Complex and may be subject to a ban on entering the SUNA Complex.
6. By purchasing, holding, using, or accepting tickets to a SUNA Complex event, Attendees accept these Conditions of Entry. Attendees are admitted into the SUNA Complex at their own risk and choose to do so under these Conditions of Entry. To the extent permitted by law, no liability for loss, injury or damage will be accepted by SUNA.

### CODE OF CONDUCT

7. SUNA is committed to providing a safe and enjoyable environment for Attendees. All Attendees must adhere to the following Code of Conduct, whilst attending the SUNA Complex:
  - Support your team in a loud, passionate, and enthusiastic manner, where appropriate.
  - Spectators, including players and officials (not in play) must not enter restricted areas or attempt to enter the court of play without expressed permission.
  - Respect of all ages, regardless of team affiliation.
  - Actively foster a family-friendly environment.
  - Use appropriate language, without threatening, foul or abusive content based on race, religion, sexuality, or gender.
  - Refrain from using offensive or obscene gestures.
8. Comply with requests from SUNA staff, SA Police and other security personnel regarding venue operations and emergency response procedures.

9. Attendees who cause a disturbance, are offensive, discriminatory, display anti-social behaviour, use foul or abusive language, make racial or threatening remarks or gestures, commit indecent exposure, or refuse to comply with reasonable requests made by SUNA (as determined by SUNA in its sole discretion) may be evicted from the SUNA Complex and for a period of time as determined by SUNA.
10. Attendees bringing personal items into SUNA do so at their own risk. SUNA cannot be held responsible for any damage, loss, or theft of an Attendee's personal property.
11. Attendees are required to take appropriate self-care for their sun protection and hydration.
12. Attendees must not sell any goods or services or give away political, religious, advertising, or promotional materials without the prior, explicit written consent of SUNA.
13. Attendees may not conduct public surveys or opinion polls or solicit money, donations, or subscriptions from members of the public, without the prior, explicit written consent of SUNA.
14. Any Attendee found mistreating, tampering, defacing, or damaging any part of SUNA or the surrounds will be evicted from the SUNA Complex and may face prosecution.
15. Cameras including mobile telephones with camera interfacing must not be used in areas such as change rooms, parenting rooms and toilets.
16. SUNA reserves the right to close SUNA's gates regardless of whether or not all persons claiming a right of entry have gained admission to the SUNA Complex, if in the opinion of SUNA, the admission of further persons to the SUNA Complex would or might endanger the safety of those persons who seek admission or who have already been admitted.
17. Some sporting and other activities are dangerous. Attendees viewing such activities do so at their own risk.
18. Attendees enter, access, or otherwise use the SUNA Complex at their own risk. To the extent permitted by law, SUNA and their representatives, officers, and employees will not be liable to Attendees for any demands, claims, proceedings, liabilities, loss or damage, (including without limitation, loss or damage caused by or associated with the negligence of SUNA or its representatives, agents, officers, or employees, and incidental and consequential loss or damage), arising in any manner wholly or partly from or in connection with that Attendee's access or use of the SUNA Complex.

#### **COVID-19**

19. SUNA, working in consultation with relevant authorities, prioritises the health and safety of Attendees and staff above all else. Attendees acknowledge that, even with control measures in place at the SUNA Complex, there remains an unquantifiable risk of transmission of viral illness,

including COVID-19, at any event from any source. By attending the SUNA Complex, Attendees acknowledge and agree that they have considered those risks and their own personal circumstances, including any health condition or vulnerability that Attendees may have, and the circumstances of persons with whom Attendees will be in close contact following attendance at the SUNA Complex.

20. Attendees acknowledge that, for a small number of people, COVID-19 has very serious health consequences. SUNA expressly relies on Attendees to bring this health issue waiver to the attention of any guest(s) of the Attendees. SUNA will rely on this health issue waiver and proceed on the basis that all Attendees acknowledge and accept these risks to enter the SUNA Complex.
21. The SUNA Complex is a place of mass gathering whereby there is an unquantifiable risk of transmission of viral illnesses, including COVID-19, and other diseases that may have serious impacts on personal health, including death. Attendees accepts this unquantifiable risk and releases SUNA from any liability whatsoever arising out of, relating to or in connection with any transmission or contraction of COVID-19 at the SUNA Complex.
22. Attendees acknowledge that they are not permitted to attend the SUNA Complex if they have been directed to self-isolate or quarantine by SA Health pursuant to any lawful direction.
23. Attendees may be denied entry to the SUNA Complex if they have or show cold or flu like symptoms that may place persons at risk or endanger or impact on public health.
24. All Attendees of the SUNA Complex must:
  - Abide by any lawful directions issued pursuant to the Emergency Management Act 2004 (SA) or otherwise, including any applicable COVID Management Plan, COVID Safe Plan or other requirements of a direction issued under that Act or any subsequent or related Act or regulation by any governmental authority.
  - Abide by all and any additional measures implemented by SUNA or other venue manager to reduce the risk of COVID-19 entering the SUNA Complex or being transmitted within the SUNA Complex.
  - Practice physical distancing wherever possible.
  - Follow directions of SUNA staff (including authorised contractors) (and including directions with respect to wearing of masks, if required).
  - Abide by any entry arrangement implemented.
  - Follow directions of SUNA staff (including authorised contractors) when leaving the SUNA Complex.

#### **PROHIBITED ITEMS**

25. SUNA may deny entry to or remove any Attendee from the SUNA Complex, who possesses any of the prohibited items as listed in clause 26 below ('Prohibited Items'), and such Attendee may be subject to a ban on entering the SUNA Complex (as determined by SUNA in its sole discretion).

26. A person may be prohibited from bringing the following items into the SUNA Complex unless a current and lawful exemption in writing has been provided by SUNA: Any item, the improper use of which is reasonably considered by SUNA as being able to cause injury, nuisance or offence to any other person attending the SUNA Complex. This includes but is not limited to the following.
- Alcoholic drinks.
  - Animals (except guide dogs and other bona fide assistance animals).
  - Bicycles, scooters, skateboards and the like are only to be ridden in the big shed area. All other areas are prohibited.
  - Balls, including but not limited to cricket balls and footballs (but for clarity and the avoidance of doubt, this does not include netballs).
  - Flares, fireworks, laser pointers.
  - Drones.
  - Confetti or shredded paper.
  - Illicit drugs.
  - Weapons, firearms & knives (or any other object that could be used as a weapon) including toy or imitation weapons.
  - Oversized signs, banners or flags that are considered by SUNA as capable of causing a nuisance.
  - Loud hailers, megaphones, and musical instruments of any nature (including vuvuzelas, horns, whistles, and drums).
27. The use of photographic, video or audio equipment for commercial purposes is not permitted within the SUNA Complex, without the prior, explicit written consent of SUNA.
28. Any Prohibited Items may be confiscated by SUNA if subsequently found on a person, upon or following entry into the SUNA Complex.
29. SUNA is not responsible for, and will not be held liable by any person, for loss, theft, or damage to any such Prohibited Items left by any persons in or around the SUNA Complex.
30. Specific conditions may apply for some events regarding the entry and use of musical instruments or devices.

#### **DRESS CODE**

31. Attendees are requested to, at minimum, be appropriately clothed for a public venue and footwear must be worn at all times.
32. Attendees must not wear or display items which bear offensive, racist, radical, fanatical, inflammatory, obscene, derogatory, or provocative slogans, signage, or logos.
33. Attendees must not wear or display any item for the sole or dominant purpose of ambush marketing.

34. Attendees must not wear, display, or possess items which bear street gang or motorcycle gang colours, including and not limited to patches, jackets, T-shirts, badges, other clothing or paraphernalia or items bearing a motorcycles gang's insignia.
35. SUNA reserves the right to refuse admission to any person, who in the opinion of SUNA personnel (including employees and authorised contractors), is deemed to be inappropriately attired.

#### **CCTV IN OPERATION AND RECORDING**

36. Please note 24-hour closed circuit television surveillance operates throughout the SUNA Complex.
37. Security cameras operate around and within the SUNA Complex and Attendees may be filmed, photographed, or otherwise recorded.
38. Attendees may be filmed, recorded, or photographed by official photographers/ videographers and these images or recordings may be used without the consent of, or payment or provision of other compensation to, attendees for all manner of promotional purposes.

#### **SMOKE-FREE**

39. The SUNA Complex is a smoke-free venue (both inside and on the surrounding outside courts and car park). This includes the use of e-cigarettes.

#### **CHANGE**

40. SUNA reserves the right to replace or vary these Conditions of Entry at any time and without notice. Any updated conditions of entry will be available via the SUNA website.

#### Rationale

We recognise our role to meet our legal obligations for duty of care, which is considered in this policy and consequent actions and decisions of SUNA.

#### Document Control
